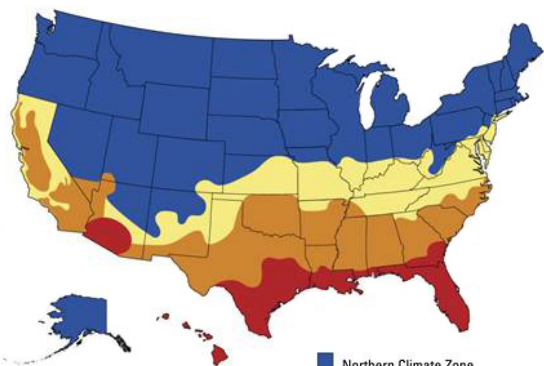


Atrium Windows and Doors certifies that our exterior vinyl windows and patio doors are available with Energy Star qualified options (e.g., the "Ultra Low-E Glass with Argon Gas" option) and may be eligible for a tax credit.

**NOTE:** Each Energy Star climate zone requires separate values for compliance. Please verify actual product thermal performance to ensure Energy Star criteria is met. Series 8100 Single Hung is not eligible for federal tax credit in the Northern Climate Zone.

The Energy Star program for windows divides the country into four distinct climate zones to recognize the varying heating and cooling months among the states. For patio doors, there is only one U-Factor and one Solar Heat Gain Coefficient (SHGC) requirement for Energy Star compliance.
